

facing the future by Ros Scott

Politics is, of course, an uncertain business.

But to paraphrase Donald Rumsfeld, there are certain uncertainties, and the formation of the Westminster Coalition Government has taken us into the realm of uncertain uncertainties.

Our new situation requires clear and firm leadership from the top of the Party, but our history tells us that we work best and are most successful when we all work together for a common goal.

This will require enormous efforts from all parts of the Party and the period since the announcement of the Coalition has been spent in a frenzy of activity in Parliament, Cowley Street and in the Federal Committees. But this is only the start.

As a way of kicking off a process which will involve members at this early stage, the Federal Executive has agreed to hold a consultative session in Liverpool, where conference representatives both individually and as members of groups and associations can discuss the challenges we face, the opportunities which being in Government brings to us and how we move forward.

Our Party's success in the future will, like its success in the past, be built on the commitment and hard work of its members and activists.

There is no doubt that this country has had an entrenched political system based on adversarial positioning and the dialogue of distrust and rejection.

The Coalition Government provides us with a welcome opportunity to show how things can be different – that coalitions can be a new form of politics which is both effective and useful. In that, Westminster is following the lead shown in Scotland and Wales and in many councils up and down the land.

The best advocates for this change are our members and activists who see it as part of their role to explain what it is we are seeking to achieve, to represent the Party and defend it where necessary.

This brings us to consideration of how we recruit, support and inform our members. And beyond that how we link the views of members and activists back into the Parliamentary Party at Westminster.

The consultative session will be about the Party as a whole – in every community, the Devolved Assemblies and in Europe as well as in Westminster. It's about how we create a Liberal movement which articulates our beliefs and values across the country.

liberals and liverpool

As a student in the mid-1970s the very word 'Liverpool' excited me.

Here was a great city, albeit one with equally great problems – and at a time when our influence elsewhere hardly existed, it was being run by Liberals!

The party of Trevor Jones and Cyril Carr, David Alton and Mike Storey, made the breakthrough in 1973 and we have led Liverpool City Council, on and off, for half of the years since then.

Politics here can be rough and raw; running Liverpool isn't easy. Our conference centre is located in the ward I represented from 1980 to 1984. For decades it had been the safest Labour seat in England, with Liberals languishing behind the Communists. It included two cathedrals, but my voters lived in council flats in an environment that was as grim as anything in Britain.

The three years I served as a committee chairman gave me a sense

of achievement that is only sometimes rivalled by my work today in the European Parliament.

I am proud of that time, but I also remember it as one when Thatcherite deflationery policy cost Merseyside 60,000 jobs. Labour's 'Militant Tendency' were the beneficiaries of the anger and despair that generated, and their actions fouled the city's reputation for years.

I took the political lessons I had learnt and applied them elsewhere, but others stayed and have since changed Liverpool hugely for the good. Liberal Democrats at our conference will see the dramatic improvements made to the city centre. Public services are vastly better, the parks and riverside environment are a treat, exam results are above average, and the crime rate is low.

But this begs some questions. The quality of life in Liverpool can be better than in London, property is cheaper, costs are lower, and transport links are good – so why is the economy here still fragile? Indeed, why is the nation's economy so skewed in favour of the

South East? Surely there is a failure of market forces that needs to be corrected by government intervention?

liberals and liverpool continued

There's a lot to be done. In opposition, Liberal Democrats called for civil servants to be moved away from London; now we can influence this.

A government wanting to save money can insist that the public sector looks beyond the City for financial, legal and other services.

The experience of the USA's Community Reinvestment Act could be used to force banks to take a direct involvement in the regeneration of inner-city communities. And let's remember that councils need new financial freedoms if greater investments are to be encouraged.

Enjoy your time at conference. The agenda of the coalition government will be the constant subject of debate in the hall and in the bars.

Liberals in Liverpool have known for a long time that politics is about winning power and using it effectively. People here will judge the government by what it does to improve the prospects of cities like this.

local elections 2011

5th May 2011 is turning out to be a big day for the Party. The referendum on Fairer Votes, General Elections for the Scottish Parliament and Welsh Assembly, plus local elections in most of England.

2011 is the biggest 'round' in the four year cycle of local elections – nearly 9,500 councillors up for election in most of England outside of London. One of our two Elected Mayors, Dave Hodgson in Bedford, is also up for election as well as many parish and town councillors.

What makes the 2011 round of local elections particularly challenging is that it includes the many councils who have 'all-up' elections, as well as those by thirds. All-ups have particular issues – its easier to see quite radical change in the number of councillors in one go (as we saw in London this year). Also some areas find it harder to keep up campaigning right through the four year period.

Challenges for 2011

This will be our first time ever (in England) where we have to fight at a local level the party who are our coalition partners at a national level. Across many areas it's a Lib Dem / Tory battle and we need to be clear in how we let people know why a Lib Dem vote locally will make a real difference.

The AV referendum is going to be on the same day. Again uncharted territory, but materials will be on their way to help people build the campaigning into *FOCUS* and other materials. And for the first time in 15

years we'll be fighting Labour in opposition (and we're in Government) – not the same as we're used to, but given the mess they left the country in, not impossible.

Last time these seats were fought, 2007, was not our best year. We lost nearly 250 councillors, Labour lost 500, the Conservatives gained nearly 1000. This time nearly 1900 Lib Dem Councillors face the electorate – not too far short of half of our total.

Help is at hand

There is plenty on offer this Conference to help us plan effectively for 2011. There is a busy training programme from ALDC, the Campaigns Department and others. Look out for the regional Election Planning Workshops and for the new 'Skills Builder' sessions aimed at giving you the tools to go back and train other members and helpers on how to win!

Right through to the election there will be templates and campaign ideas from both ALDC and the Campaigns Department to suit all different levels and abilities – come and talk to us at our stand if you need to know more.

Remember one simple fact – last time these seats were in up in 2007, Councillors who were ALDC members were **three and a half times** more likely to be re-elected than other Lib Dems!

access

Entry to the **ACC** is via the **Cityside Entrance** on **Monarchs Quay**.

Access to all areas of the ACC is possible only with a valid, visible conference photo pass worn with the official lanyard. You will be asked to show your pass when you enter the ACC and you are required to wear the pass with the lanyard visible at all times within the building. Please allow time for security check queues at the ACC during key times – particularly after lunch and ahead of popular events. See security on page 11.

If you are attending a training or fringe session in the **Jurys Inn**, **Hilton Liverpool** or **Holiday Inn Express**, conference photo passes are not necessary, unless you are attending a party training session, where you may be asked to show a valid photo pass or party membership card.

childcare

We offer a conference **crèche** for members with children aged 6 weeks to 10 years. **As crèche staff** *are not allowed to accept children who are not pre-registered and the deadline for crèche registrations has now passed, further bookings cannot be accepted.* Information on how to register your child for next year's spring conference will be available in due course at

A **babysitting** service can be booked via our crèche provider *Tinies* on 0845 330 1419. The booking fee is £25+VAT per nanny in advance, then £8.00 an hour (before midnight) or £10.00 an hour (after midnight) payable to the nanny at the end of the evening. There is a minimum booking of 3 hours, you must give at least 24 hours notice and each nanny can look after a maximum of two children in one room. All arrangements and payment are to be made to *Tinies* directly.

cloakroom

Under no circumstances will any large bags or suitcases be allowed into the ACC.

There is a cloakroom in the **Galleria** on the **ground** floor of the ACC. A \pounds 1 charge per item applies.

On the last morning of conference, Wednesday 22nd September, your hotel should be able to store your luggage for you after checkout.

Alternatively suitcases may be deposited at the Jurys Inn hotel and must be collected by no later than 18.00. A small luggage charge may apply for nonresidents of the Jurys Inn.

internet access

security and safety

The safety of the people who live in, work in and visit Merseyside is Merseyside Police's top priority. The Liberal Democrat Party has received and accepted advice from Merseyside Police regarding security measures for the autumn conference 2010. As a result, an enhanced security operation will be running for the duration of the conference. These measures have been agreed and put in place to ensure, as fully as possible, the safety of everyone attending the conference, as well as the residents and employees surrounding the venue.

All those attending conference must have a pass issued by the Party in order to gain access to the conference venue. Conference photo passes must be worn visibly at all times within the ACC. Anyone found in the secure area without a valid pass will be escorted from the building.

Everyone will be subject to an 'airport type' search process at the entry point. This will include metal detecting archways and x-ray searches of bags. Anyone wishing to bring small items into the venue will be able to pass them through the entry point x-ray machines. The maximum size is 640mm (W) x 430mm (H).

Packages too large will be subject to physical search by security staff. Boxes and packages should be left unsealed wherever possible. Under no circumstances will any large bags or suitcases be allowed into the ACC. Any bag left unattended will be brought to the attention of the police and may be removed and/or destroyed.

In order to ensure your process through the new security measures is as quick as possible please only bring essential items with you into the centre.







acc

Access to the ACC is via the Cityside Entrance on Monarchs Quay. There are lifts in the Galleria which give access to the **exhibition** and **auditorium** on the lower ground floor and the **fringe rooms** on Level 3.

The seating area in the **auditorium** (in the Arena on the lower ground floor of the ACC) will be mostly on the flat. Ramped access to the stage is available to the left of the stage.

Within the ACC, the information desk features a fixed loop hearing system. An induction loop is available in specific seating areas within the auditorium. Please ask a steward to direct you to these seats.

Sign language interpretation will be provided during all sessions held in the auditorium. A number of seats are reserved in front of stage right for representatives using this service.

For representatives who would benefit from being closer to the stage due to a visual impairment, a small number of seats are reserved at the front of the auditorium.


