F13 Emergency motion: Unaccompanied Asylum-seeking Children

10 members

Mover: Baroness Shas Sheehan (Shadow Secretary of State for International Development) Summation: Cllr Chris White

1 Conference notes that:

- A. More people have been internationally displaced by conflict and crisis than at any time since World
 War II and many of the displaced are currently seeking refuge in Europe from Syria alone, three
 million have been displaced by conflict and crisis.
- B. In 2015 over 90,000 unaccompanied minors applied for asylum in Europe many tens of thousands more have reached Europe but not claimed asylum.
- 7 C. The Government continues to obstruct efforts to create safe and legal routes for refugees arguing that this creates 'pull factors', an argument that has not been evidenced.
- 9 D. Section 67 of the Immigration Act 2016, which established a scheme to allow the resettlement of unaccompanied child refugees, was passed as an amendment to the Act (known as the 'Dubs Amendment') with cross party support after a groundswell of public support and campaigning.

12 Conference notes with concern that:

- i) In February 2017, the Government announced the closure of the resettlement scheme expecting to take only 350 child refugees via this route predominantly from Calais.
- 15 ii) The Government cited limitations in council capacity to accommodate unaccompanied child refugees 16 contrary to evidence suggesting that councils had spare capacity and would be willing to take more 17 unaccompanied minors from Europe.
- 18 iii) A recent amendment which, if accepted, would have obliged councils to identify their capacity to accommodate unaccompanied child refugees, was defeated in the Commons by a very slim majority.

20 Conference believes that:

- 21 a) The decision to close the resettlement scheme is a betrayal of the wishes of the British people.
- 22 b) Government should live up to the spirit of the Dubs amendment.
- 23 c) It is the responsibility of central government to provide funding for the resettlement of unaccompanied child refugees to ensure councils are able to deliver on the UK's obligations to act as
- a sanctuary for those in need.

26 Conference calls for the Government to:

- 1. Reopen the Dubs scheme immediately.
- 28 2. Re-engage with local authorities to establish actual capacity for resettlement, and publish this capacity.
- 30 3. Continue to work with European and other international partners to establish safe and legal routes to resettlement.

Applicability: Federal except 2. (lines 28-29) which is England only.

- 3 Delete v) (lines 28–30) and insert:

- 5 In vi) (line 31–32), delete '(other than those who are mainly or exclusively responsible for providing religious
- 6 instruction)'.
- 7 Delete 1. a) (line 44) and insert:
- 8 a) Does not contain any religious instruction.

- 9 In 2. (lines 49-52), delete all words after 'basis of merit'.
- 10 In 3. (lines 53–57), delete 'Allows state-funded schools to hold acts of worship and provide religious
- instruction' and insert 'Allows children to choose freely whether or not they wish to engage in acts of
- 12 worship of their choice'.
- 13 Delete 4. (lines 58–62).

The Options and Amendment will be voted on in the following order:

- The first vote will be between Option A and Option B.
- The second vote will be between the winner of the first vote and Option C.
- The third vote will be on Amendment One.
- The final vote will be on the motion as a whole as amended.

Background briefing

This motion updates and develops policy on the role of faith in state schools. The motion supports schools with a religious character having a positive role to play in the education system, while making a clear distinction between religious education and religious instruction, and strictly limiting the roles in schools where the faith of the applicant can be a factor in appointment. The motion also ends the requirement on all non-denominational schools to have a collective act of worship of a broadly Christian character. The motion goes on to set out a series of options for how far faith schools should be allowed to select their pupils by faith when school places are oversubscribed.

Existing policy is set out in policy paper Equity and Excellence (2009), as amended by conference.

F17 Associate Citizenship of the European Union

Amendment One

Brussels and Europe Liberal Democrats Mover: Catherine Bearder MEP Summation: Giles Goodall

- 1 After 3. (line 31), add:
- 2 4. The rights of EU citizens in the UK are guaranteed, noting that without a guarantee on EU citizens'
- 3 rights, EU Member States and the European Parliament may refuse a reciprocal arrangement for
- 4 British citizens to keep their EU citizenship.
- 5 In a) (line 18), after 'citizenship' insert 'as well as British citizens in other EU countries,'.
- 6 In b) (line 21), after 'anyone' insert 'including those British citizens denied a vote due to their residence in
- 7 another EU country for over 15 years'.

Background briefing

This motion creates new policy on associate citizenship of the EU. In particular, it calls for the government to ensure that British citizens can apply for associate EU citizenship, and that this status provides as many of the rights of full EU citizenship as possible.
